The current Uniqsis staff will continue to offer specialist support for the flow chemistry products within Asynt, and in September we are extending our Flow Chemistry support team with an additional experienced flow chemistry scientist to help with all current Uniqsis customers' requirements.

For the remainder of 2024, the Uniqsis staff will continue to work from the existing premises in Comberton before transferring to new purpose-build facilities in Isleham CB7 UK in 2025.

 need to be paid to Uniqsis, as is currently the case.
